1. Apologies for Absence and Declarations of Interest

2. Minutes – 27 January 2021

The minutes of the meeting on 27 January 2021 were agreed as a correct record and signed by the Mayor.

3. Exclusion of the Press and Public

On being proposed by the Mayor with the unanimous agreement of the Committee it was resolved to:
